Safety Meeting @ 10:00 a.m. – Match Following the Safety Meeting

ALL shooters must attend the general safety meeting and should familiarize themselves with USPSA Rules available on the USPSA website.

SET-UP will be on Saturday morning - please come out at 8:30 a.m. to get stages ready for the match.

IMPORTANT! We urge shooters to register with practiscore.com.

Alternate way to register: Go back to the website and click on <Register Through Practiscore.com>. After you register, you will get an email to confirm your registration and then you can choose a squad on which you'd like to shoot. If you don't register online, don't worry! You can still register on Saturday, but you might not have a choice of your squad.

2. Five stages are planned to include a classifier stage.

3. COST/EQUIPMENT – Match Fee \$20. Bring a holster, 5-6 magazines, and mag pouches, 150 rounds of ammo, eye and ear protection.

4. Membership in USPSA is not required – all shooters welcome. Spectators welcome also, just make sure you have your eye and ear protection.
